Coordinating Council Nominations Sought

The ND Library Coordinating Council (NDLCC) serves as the State Library's advisory board. The NDLCC assists with the creation and implementation of the Library Vision strategic plan, the grants, and serves as the external database review committee. The Governor appoints NDLCC members according to Century Code. Due to a vacancy, we are seeking nominations for the Special Populations seat. The person that is appointed by the Governor will serve the remainder of this term which is through 06/30/24. The Special Populations seat must be filled by a librarian or library staff working in a North Dakota Library and represent disabled, economically disadvantaged, and minority populations.

Nominations, including self-nominations, may be sent to the NDSL Administrative email at ndsladmn@nd.gov by December 17. The State Library will compile the list of applicants and forward it to the Governor's office. The Talking Books program at the North Dakota State Library provides eligible patrons with free access to audiobooks and magazines. It is administered by the National Library Service for the Blind and Physically Handicapped (NLS), a division of the Library of Congress.

Our Reader's Advisors are available to help patrons fulfill requests, help with players, and answer questions about your account and application. Whether you call or come in to inquire or enlist in our help with Talking Books, you will be met with people who are passionate about the work they perform and the services they provide.



You'll find books about North Dakota as well as ones authored by North Dakotans. There is also a wide variety of fiction and non-fiction, which is sure to please any audience. And, with Duplication on Demand, we can download multiple books onto one cartridge.

Eligibility Requirements:

- Persons who are totally or legally blind
- Persons with visual disabilities who are unable to read standard print clearly and comfortably for a reasonable length of time
- Persons with physical disabilities who cannot hold a book, turn pages, or focus on printed material due to muscle or nerve deterioration, paralysis, or some other disabling condition

Material Challenges

Last week, I dug into researching using primary sources. Week four brings the topic of material challenges.

Challenges to library materials have surged. With this comes uncertainty, particularly in librarians who have had little experience with material challenges in the past. Banned Books Week offers valuable advice on how to handle such challenges (Gomez, 2019):

- 1) Be prepared. It is usually easier to be proactive than reactive. Make sure your library has a strong Collection Development Policy, complete with a Reconsideration of Material Policy.
- 2) Remember your community. Part of the role of a library is to cater to the information and entertainment wants and needs of ALL your patrons. Just because one person disagrees with an item found in a library does not mean that all patrons should be denied access to that material.
- 3) Keep it friendly. In many cases of challenges, the concerned individual simply wants to be heard. Additionally, keeping a calm exterior can help calm the other person down. Even in the case of a formal complaint being filed, keep your emotions professional and kind.
